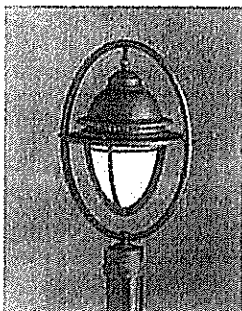

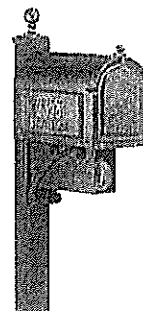

ARCHITECTURAL DESIGN CONTROL COMMITTEE

In order to approve building plans in a timely manner, we are requesting that each builder provide the following to the Design Control Committee:

- a) Name of Owner, Development and Lot Number
- b) Name of Builder, Address and Phone Number
- c) Two Sets or Copies of Plans (8.5x11 or Legal Size)
(Floor Plans and Exterior Elevations required)
- d) The Total Square Footage of Living Space
- e) Exterior Specifications
(Material, Color, Style, etc.)
- f) Site Plan Illustrating Footprint in Relation to Setback Requirements
(Landscape Schematic Design and the location of any trees to be removed required)

A cover sheet attached to reduced plans with above information would speed the approval process. Failure to have any of the above information could cause rejection of plans. We can accept plans by the e-mail listed above.
